

OPERATIONS REPORT

In the calendar year ending 31 Dec 2008, Flt 56 performed 99 surface patrols, with 14 having been done in December.

All current coxswains (8) (Including 2 visitors to D-7) and crew (14) have exceeded their minimum 12 underway hours for re-certifications for the year 2008. All coxswains and crew have also attended the 2008 OPS workshop & required TCTclasses.

ESCORTING COAST GUARD CUTTER

On Sunday, December 14, 2008, the term "patrol boat" took on an entirely new meaning for 7 Auxiliarists from Flotillas 56 and 58. More importantly, what occurred that day demonstrated once again the effective working relationship forged between the Coast Guard and the Auxiliary. Also successfully demonstrated was another dimension of the relationship: close cooperation between the two Flotillas working with the Coast Guard.

The mission: escort the 110' Coast Guard Cutter *Drummond* north from the turning basin at Ft. Pierce Inlet to its destination at Harbor Branch. The Auxiliary role was to ensure the safety of small craft along the route by keeping the ICW and Harbor Branch channels clear for the big cutter. The two Auxiliary patrol boats alerted southbound and fishing vessels of the approaching Coast Guard Cutter. Their Captains were advised of the cutter's wake and need for deep-water operation. After pumping out her water ballast to reduce draft, *Drummond* made its way to Harbor Branch without incident or disrupting navigation in the much-travelled ICW. Lt. Sanders, *Drummond's* commanding officer, was very appreciative of the Auxiliary's assistance.

Drummond, built in Louisiana in 1988, is a well-armed "Island" class patrol boat displacing 155 tons and capable of 30 knots from almost 6,000 bhp.

A CPR class to be taught by Gary and Terry Barth of Flotilla 58 is scheduled for Jan 26^{th} 1630 - 2030 at the American Legion in Sebastian. As of this writing on Jan 6^{th} eight of our members have signed up for the training.

Even if you have had this training in the past it could be well worth the effort to take it again. Some procedures and recommendations have changed and it pays to be current. The life you save may be mine.

The first Member Training class of 2009 will be the Auxiliary Advanced Coastal Navigation (AUXACN). This replaces the Auxiliary Navigation A (AUXNAV A) and Auxiliary Navigation B (AUXNAV B).

PE – REPORT


I hope we can improve attendance in 2009. We have 2 members in training for Instructor, and that will help cover some of the summer classes when we are short handed.

BOATERS EDUCATION EDITORIAL

The following editorial appeared in the Vero Beach Press Journal on Friday January 9th.

Editorial: Requiring all Florida boaters to complete training courses would reduce fatalitiesWith rare exceptions, Florida leads the nation each year in boating accidents, injuries and deaths. In 2007 there were 685 boating fatalities nationwide.

The Florida Fish and Wildlife Conservation Commission is committed to boating safety.

The same cannot be said of Florida legislators.

The commission recently approved boating restrictions — reductions in vessel speed limits over specified portions of the Martin County Intracoastal and Okeechobee waterways — at a recent meeting in Key West. The goal? To reduce boating accidents in "high risk" areas, which were identified following several public meetings and an in-depth statistical analysis of Martin County waters.

The commission understands the role "speed" plays in causing injuries and deaths. It also understands the value of education — a concept that seems to escape state lawmakers.

There is a direct correlation between the training a boat operator receives and his/her ability to operate a water-craft safely. The 2007 Recreational Boating Statistics — produced jointly by the U.S. Department of Homeland Security and the U.S. Coast Guard — supports this conclusion.

With rare exceptions, Florida leads the nation each year in boating accidents, injuries and deaths. In 2007 there were 685 boating fatalities nationwide. Of this total, 10.9 percent of the deaths (75) occurred in the Sunshine State.

One of the major, causative factors is a gaping hole in state law.

Only people 21 and younger are required to complete an approved boating-safety education course in Florida. As a result, the skill level of boaters is dependent upon their willingness to enroll in voluntary training courses offered by sanctioned instructors.

Does boater education make a difference? Yes, a big one.

The annual report found that, of 376 boating fatalities in 2007 where the operator's instruction level was determined, 282 received no formal instruction whatsoever.

"Only 14 percent of deaths (nationwide) occurred on vessels where the operator had received boating-safety instructions," the report said.

During the 2008 Legislature, the Florida Fish and Wildlife Conservation Commission's Boating Advisory Council advocated a proposal that would have established an 11-year phase-in period for every vessel operator to pass a boating-safety course. The age requirement would have been increased by five years, every year. State lawmakers rejected the proposal.

If the legislature is serious about reducing boating injuries and fatalities, it will require mandatory training for everyone who operates a watercraft in the Sunshine State.

The facts speak for themselves.

BOATING SAFETY

Key national findings to consider the next time you operate a watercraft in Florida waters:

More than two-thirds of fatal boating accident victims drowned; of those, 90 percent were not wearing a life jacket.

Three out of four boaters who drowned were using vessels less than 21 feet in length.

Operator inattention, careless/reckless operation, passenger/skier behavior, excessive speed and alcohol use rank as the top five primary contributing factors in accidents.

Alcohol use is the leading contributing factor in fatal boating accidents. It was listed as the leading factor in 21 percent of the deaths.
