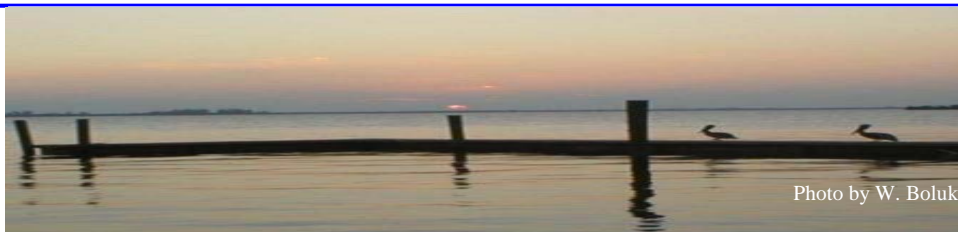

Unlike the 7030's, the 7029's are generated by the individual Auxiliarist. Thru this self-reporting, the Coast Guard gets a true account of the full effort put forth by its Auxiliary. Also, it is the only means each of us gets to actually account for our time. So, I am encouraging increased use of the 7029's to report our time. If not for the job, think of the jewelry

Kudos to those Vessel Examiners who participated in the Safe Boating Week Vessel Safety exam blitz while I was away in Kentucky last month. Congratulations are also in order to Bill Boluk who became recertified as a vessel safety examiner.

Completing exams is a rewarding experience that includes teaching individuals about boating safety but also includes the reward of accomplishing a much needed service to the general public. As mentioned in an earlier issue of The Pilot, Florida remains the “Fishing Capital of the World” with 2.8 million anglers. In Indian River County alone, these fishing enthusiasts have 10,493 pleasure craft registered as 25 feet or less in length. It looks like we have our work cut out for us!

Another exciting thing that has happened is that our flotilla has surpassed our goal for completed vessel safety exams this year. We presently have completed 118 exams and it’s only June! Our goal for the entire year was 112.

## WHATS NEW ON THE WEB

### Weakened" Hurricane Systems Harm Boats Far Inland, Too

Historically, whenever a hurricane comes ashore along the Gulf or Atlantic coasts, that's where the most damage is found. But even though a tropical storm system weakens significantly as it moves over land, it will often continue to carry a significant punch over a wide area inland - possibly hundreds of miles from landfall. With the start of the 2009 hurricane season June 1, Boat US says inland boat owners should take these storms seriously and make preparations, even though the system may no longer be classified as a hurricane. Boaters can get some free hurricane preparation help, including a hurricane preparation worksheet, an in-depth Guide to Preparing Boats and Marinas for Hurricanes, and checklists for what to do before and after a hurricane strikes, from the Boat US Hurricane Resource Center. The web site also helps boaters monitor incoming storms with up-to-the-minute storm tracking tools and live satellite imagery.

Please see the new policy revisions related to the AUXILIARY SEARCH, COORDINATION, AND EXECUTION (AUXSC&E ) COURSE TRAINING POLICY REVISION 1. (DATED: 1 May 2009 ). In order to be admitted to an AUXSC&E or AUXSC&ETTT course, the student must complete the AUXSC&E Registration Form. This registration form is a new requirement. Effective 1, June 2009: successful completion of the AUX-NAV course is a prerequisite before taking the AUXSC&E TTT course. All current AUXSC&ETTT qualified instructors are not subject to this requirement. Please review the Policy Revision. ## U.S. Coast Guard Aids to Navigation Team Ft. Lauderdale: “Together Everyone Achieves More”

On May 1st, the Ft. Pierce Aids to Navigation Team and I attended the Change of Command of the Ft. Lauderdale ANT in Ft. Lauderdale. We used the Cutter Cormorant’s van and left very early in the morning. An early breakfast at IHOP in Fort Lauderdale was the gathering place for many who traveled to attend.

The Aids to Navigation Team Ft. Lauderdale was commissioned in 2004 after being moved from Miami. The unit consists of eight enlisted personnel, and two vessels, a 23’ and 26’ TANB. The unit’s area of responsibility is from Jupiter Inlet on the east coast and runs south to Key Largo. Their area continues west through the Everglades National Park, proceeding north to Naples.

Since its commissioning, the team has helped with Habitat for Humanity and responded to 3 major hurricanes falling out of their AOR. In 2005 the unit made CG History being a part of the first Mobilized ATON Strike team to open up the vital ports and waterways from Biloxi to Lake Pontchartrain after Hurricane Katrina made landfall.

Captain James Fitton, Commander, Sector Miami presided at the Command. Senior Chief Boatswain’s Mate Gregory “Mike” Winans was relieved by Prospective Officer in Charge Chief Boatswain’s Mate Dennis T. Southworth who will be the Team’s third Officer in Charge.

The Change of Command Ceremony marks the formal passing of responsibility, authority and accountability of command from one officer to another.

## **CRITERIA FOR SERVICE AWARDS**



### **Annual Service Performance Award-Operations**

The Operations Service award is awarded for supporting Coast Guard units and missions, including surface operations, air operations, and operational watchstanding (such as communications watchstander, OOD, manning the SAR desk, etc.). The operational O device for underway (excluding underway for training), surface mission activity (sixty or more hours), or for airborne aviation mission activity (excluding training) (thirty or more hours). Support for on-the-water readiness exercises does qualify as operational service. No combination of surface and air operations is allowable for this award. Support activity includes categories 01, 02, 03, 24, 25, 26, 27, 28, 30, 31, 32, 33, 51, 52, 53, and 54 identified on AUXDATA report 4. Activities 30 (AtoN-Federal) and 31 (AtoN-private) and 32 (Bridge Administration) should be for afloat activity, service ashore, for this award.



### **Annual Service Performance Award-VESSEL-PHYSICIAN VISITOR**

The VE/RBSVP Service award is awarded for completing sixty or more Vessel Safety Checks, which include examinations of recreational boats, personal watercraft, commercial fishing vessels and uninspected passenger vessels, or conducting sixty or more Recreational Boating Safety Visitor Programs or conducting a combination of VSCs, CFVEs (Commercial Fishing Vessel Exams and RBSVPs, which totals at least sixty checks/visits. Also, the award may be earned by conducting a total of twenty CFVEs.



### **Annual Service Performance Award-PE**

The Public Education Service award is awarded for IT and/or ITs aides completing thirty or more hours of instruction (in PE or Member Training), or serving as an ITs aide for sixty or more hours, or completing a combination of IT hours and ITs aide hours to total at least thirty credits (one IT hour equals one credit and one aide hour equals one-half a credit, for example, twenty hours as an IT equals twenty credits and twenty hours as an aide equals ten credits, totaling thirty credits and qualifying to receive the award).



### **Sustained Auxiliary Service**

This award is presented to an Auxiliarist contributing a documented total of 750 volunteer hours of Auxiliary service. Subsequent awards are presented for each additional 750 hours of service until the tenth award is achieved. Auxiliarist indicate multiple awards by adding 3/16-inch bronze or silver stars, until the tenth award, at which time an hourglass device will be used. This award includes a miniature medal, ribbon, and certificate. Eligibility for this award is documented by the Director, using AUXDATA information, whose staff shall then forward the initial medal/ribbon set issue and a prepared certificate to be presented per district/regional policy. Subsequent awards receive the star or hourglass device and a certificate showing the number of hours being recognized.
